- 5. To be conscious that in providing access to your personal data, you are giving express permission to use them for the purposes set forth in the Privacy and Data Protection Policy;
- 6. To be conscious that your personal data may also be used to send information and updates about new related products information;
- 7. To be conscious that your contact information may also be used to contact you via email, letter or phone calls, to request your comments and to assess your satisfaction regarding our services and products.

FERBAR has implemented procedures to assure compliance with the obligations of security in processing, on notification to the supervisory authority and owners of such data in case of its violation, impact assessment on data protection and prior consultation, according to the applicable laws.
